**Affiliate or Associate Memberships**

1. Open to any business, organization, non-profit organization or individual desiring representation in the Nauvoo Area Chamber of Commerce, but not located within the 62354 zip code.
2. Representation in promotional efforts using Illinois grant funds unless the business is located out of the state of Illinois
3. Publications (newsletter, etc)
4. Monthly minutes

Dues are payable in full as of October 1 each year. Members who join during the year will have their dues pro-rated from October 1 for the year joining and are due in full at the time of joining. Dues will be considered delinquent as of January 31 each year.
